2. Definitions

- Client: A person or entity purchasing goods or services from Milla Novo.
- Order: Any custom, webshop, or non-custom product or service provided by Milla Novo.
- Agreement: Any verbal, written, or webshop-based contract between Milla Novo and the client.
- Force Majeure: External circumstances beyond control, including illness or supply issues.
- Down Payment: The upfront payment made to start production, which is non-refundable.

3. General Terms

- 1. Milla Novo provides bespoke, handmade high-end wall hangings and designs.
- 2. These terms apply to all offers, webshop orders, and follow-up orders.
- 3. Client terms and conditions are explicitly rejected.
- 4. Acceptance of a quote, webshop order, email confirmation, or verbal agreement indicates client



acceptance of these terms.

- 4. Order Confirmation & Payment
- 1. An agreement is confirmed once the client accepts the quote or completes a webshop purchase.
- 2. A non-refundable down payment of 50% is required to start the order (for custom work). This covers time and materials.
- 3. The remaining 50% is invoiced before shipping.
- 4. Payment must be made within 7 days of invoice date.
- 5. Late payments incur statutory interest and additional recovery costs.
- 6. Products will only be delivered after full payment is received.
- 5. Returns & Cancellations
- 1. All sales are final.
- 2. No returns are accepted. Each piece is custom-made.
- 3. Webshop items are also non-returnable unless defective.
- 4. The client may cancel the order within 14 days, but the down payment is non-refundable.
- 5. If materials have already been purchased or production has started, additional cancellation fees may apply.
- 6. Milla Novo reserves the right to cancel or reschedule an order due to illness or unforeseen circumstances.
- 6. Delivery
- 1. Delivery time is discussed with the client prior to the order or indicated in the webshop.
- 2. Delivery times are indicative and not guaranteed.
- 3. Risk transfers to the client upon shipment.
- 7. Intellectual Property
- 1. All designs and products remain the intellectual property of Milla Novo.
- 2. Clients are not permitted to alter or reproduce the designs without written permission.
- 3. Milla Novo reserves the right to use images of completed works for promotional purposes, unless the client objects in writing.
- 8. Liability



- 1. Milla Novo is not liable for indirect damage, misuse, or third-party delays.
- 2. Liability is limited to the value of the order or insurance coverage.
- 9. Privacy
- 1. Personal data is handled according to GDPR regulations.
- 2. Client information is used solely to complete the order or meet legal obligations.
- 10. Final Provisions
- 1. All agreements are governed by Dutch law.
- 2. Disputes shall first be attempted to resolve through mutual consultation.
- 3. If not resolved, disputes will be submitted to the competent court in Haarlem, NL.

 - Up to 14 days before the workshop, 50% of the participation fee will be refunded.
 - Within 14 days before the workshop, no refund will be given.
- 3. If a participant is unable to attend, they may send a substitute, provided Milla Novo is notified in writing in advance.
- 4. Milla Novo reserves the right to cancel or reschedule a workshop due to insufficient participants, illness, or force majeure.
 - In case of cancellation by Milla Novo, the full fee will be refunded.
- 5. All materials, handouts, and techniques shared during the workshop remain the intellectual property of Milla Novo and may not be reproduced or commercially used without permission.
- 6. Participation in a workshop is entirely at the participant's own risk. Milla Novo is not liable for damage, loss, or theft of personal belongings or injury during the workshop.
